## Chicago Society, P.N.A. Minutes of the Board of Directors Meeting Held on October 4, 2021 At D'Agostino's restaurant, 7530 W. Oakton



- I. Call to Order: President Konopka called the meeting to order at 7:13 pm.
- II. Roll Call of Officers and Directors present: Brs. Konopka, Grzadziel, Cwiakala, Haszlakiewicz, Ciesla, Plachta, Wasilewski, Dykas, Kurdziel, Matuszczak. Absent: Brs. Kogut, Kozelka. Quorum achieved.
- III. Approval of minutes:
- IV. Correspondence: None. Bills: Receipt received for PO Box, \$139.75 to SFI for Forum, bill for dinner. Motion to accept by Br. Matuszczak, seconded by Br. Ciesla. Passed.
- V. Directors and Officers Reports:

**1st Vice-President:** Br. Chris Grzadziel – No speakers for the Business Expo meeting on October 20. Please reach out if any member wishes to speak about their business – there is still time. Motion to accept report made by Br. Dykas, seconded by Br. Haszlakiewicz. Passed.

**2nd Vice-President:** Br. Chuck Cwiakala – Next month's general meeting (November 17) will be at Great Escape with Turkey raffle. 10 to 15 turkeys will be available. December 15 meeting – Christmas dinner – with spouses/family members (for extra charge) will be limited to a maximum of 75 if held at Great Escape. Br. Kurdziel is exploring a different venue. December 6 board meeting will be a bit more upscale at Colletti's (Central & Elston). Br. Wasilewski moved to accept report, seconded by Br. Ciesla. Passed.

Secretary: Br. Haszlakiewicz - No report.

**Financial Secretary**: Br. Ciesla - report was emailed to board prior to meeting. Current balance is (Redacted). The C.S. Foundation submitted a check in the amount of \$180.00 to cover half of the PO Box cost. Br. Orwat has not paid dues for the second half of the year, his membership should be sus pended. Br. Mance did pay his dues, he should be reinstated. Motion to accept report made by Br. Wasilewski, seconded by Br. Kurdziel. Motion passed. Br. Matuszczak raised the issue of paid mem bers who don't participate in our meetings or functions. Out of 95 paid members, Br. Ro identified 24 who fall into that category and asked the board what can be done to increase their involvement. Br. Konopka took a picture of the list and suggested a special letter be sent to them addressing this issue.

**Treasurer**: Br. Plachta – report emailed to board prior to meeting. Current balance is \$60,550.07. Br. Plachta expressed surprise that we were denied our request for tax exempt status from the state of Illinois. Br. Konopka offered an explanation and indicated that the final hearing on the matter is scheduled for October 5, 2021. What follows is the email Br. Konopka received from Jessica Odigie, Special Asssistant Attorney General, ILL. Dept. of Revenue, dated October 4, 2021:

"Good afternoon, Mr. Konopka:

After a review of the answers provided in response to my 8/24/2021 questionnaire, I have a more clear understanding of the reasoning behind the Department's determination that Chicago Society of the Polish National Alliance does not meet the Department's requirements to qualify for a charitable sales tax exemption. The list below is not in any particular order and is not intended to be exhaustive.

Generally, the Department does not grant exemptions to membership based organizations because organizations in this category tend to provide, or aim to provide, a benefit to its members rather than a benefit to the public at large. Based on the stated mission of the Chicago Society of the Polish National Alliance ("the Society"), the Society intends to, among other things, "support and nurture the business and civic endeavors or its members".

The Department requires the applicant to derive its funds mainly from charity. The Society derives its funds primarily from member dues.

The Department requires the applicant to reduce a burden on the government. The Society does not reduce any burden the government currently has.

Please let me know whether you have questions or would like to discuss further. Thank you.

Br. Konopka is hoping the hearing (on Oct. 5) will lead to a more favorable resolution. Br. Matuszczak observed that the treasurer's report should include the balances of the Deserving Childrens' Fund, the Youth Fund and all checks issued in the month of the report. Motion toac ept the treasurer's report with the stated corrections was made by Br. Matuszczak and seconded by Br. Kurdziel.

**Advocate**: Br. Wasilewski – Wiecek payments are on time.

**Director of Publications**: Br. Kozelka, absent. Please send in Forum pertinent content.

Director of Outreach: Br. Matuszczak –The family receiving the financial assist is very grateful. Checking with the Yorkville camp for a good rate.

**Senior Director**: Br. Dykas – no report.

Social Activities Director: Br. Kurdziel – Deserving Children's Party Fund. Br. Matuszczak moved, that the Chairman of the Deserving Children's party have access to the moneys in the Fund for the purpose of purchasing necessary supplies and gifts, as he sees fit, without further approval from the board, subject to proper accounting, and not to exceed the amount in the fund. Se conded by Br. Kurdziel. Motion passed. Inaugural ??, January 29, 2022 Br. Grzadziel will look in to securing last years' venue – Fountaine Bleu. The required minimum (70 - 80) will need "all hands on deck". Motion to accept report made by Br. Matuszczak, seconded by, Br. Wasilewski.

**Director of Personnel:** Br. Kogut – Absent

**Social Media Committee:** Br. Grzadziel – Facebook was down...the world got better. The deserving children event and Inaugural will need to be heavily promoted.

**Custodial Committee:** Br. Wasilewski – No report

**Foundation:** - Meeting coming up at end of month.

# Tasting Room

This month's episode of taste bud tingling, liver cell destroying, booze inspiring imbibing takes us to the picturesque mountains of Uruguay. The Albariño grape features tastes and notes very similar to a dry Sauvignon Blanc, however it is not as herbal or vegetable-forward as it's more well known sibling. It tends to exhibit notes of citrus fruits, such as grape-fruit and lemons, as well as stone fruits, such as peaches and nectarines. In addition to South America, this grape varietal is also grown in the Spanish Galician regain and northwest Portugal.

In some ways I'm surprised that the wino of Uruguay has not been more commonplace on shelves of the local purveyor of what used to be the last legal drug (and still is according to the Feds). Chilean wines made quite the rage a few years ago and are not difficult to find. Perhaps it's uncommonness it what makes Albariño so interesting.

Overall this bottle is light-bodied and low in tannins but high in acid. The high acidity makes this wine refreshingly mouthwatering and best served well-chilled. Albariño should be drunk while young (preferably within 16 months) since the wine can develop undesirable flavors if left in the bottle for too long.

The Garzon bottle hit my wallet for a little over \$18 and was well worth the price. This vineyard also features a Pinot Noir rose which also gets full marks.
