Chicago Society Early History: Lodge 1450

1912 to 1916

Administration of Frank A. Osuch. This represents the formative period of the Society. Activity was directed primarily toward increasing membership and establishing a program for the organization. The annual commemoration of historical events such as the Lincoln, Kosciuszko and Pulaski Memorial manifestations were established as a definitive policy of the Society. By its efforts and accomplishments, the Society acquired a lasting prestige among the Pol-American organizations.

1917 to 1918

Administration of Michael Kitkowski. This was the period of World War I. These were indeed hard years for the officers, for it appeared when the final roll was called in 1918, that one hundred fifty members of the Chicago Society were enlisted in the Armed Forces of the United States; that every third member was a soldier and every third Society soldier was an officer in the United States Army, Navy, or Marine Corps. Every member who entered military service was corresponded with and furnished with little comforts and necessities, and his financial obligations to the parent organization, The Polish National Alliance, were advanced by the Society. The Chicago Society is proud of its war record.

1919 to 1922

Administration of Marion G. Kudlick. This period marks the establishment of a definite fiscal policy for the Society by the creation of a permanent reserve fund to assure financial stability. The activities of the protectorate over the underprivilege youth were expanded. On the initiative, the Polish Welfare Association was organized in 1921 and incorporated under the laws of Illinois in 1922. A kindred society known as the Milwaukee Society was organized in Milwaukee on December 15, 1921. Due to the extensive increase in membership, the activities if the Society became concentrated in the loop. A good fellowship committee was organized and promoted parties such as Halloween parties for the orphans and Polish picnics became a reality. The administration was noted for expansion in membership and activities and placement of the Society on a sound financial footing.

1923

Administration of Leo S. Mallek one of the founders of the Society was drafted to leadership I an effort to tide the Society over this critical period. This represented a period of transition in the history of the Society. New demands, a new headquarters and an entire change in the program. Another kindred society, known as the Detroit Society was sponsored and organized in Detroit on March 5, 1923. Lectures played a prominent part in the Society's programs during this year.

Chicago Society, P.N.A. Minutes of the Board of Directors Meeting Held on Monday March 1, 2021 Due to the corona virus emergency this was a ZOOM meeting

Call to Order: President Konopka called the meeting to order at 7:03 pm.

Roll Call of Officers and Directors present: Brs. Ciesla, Cwiakala, Dykas, Konopka, Grzadziel, Kogut, Matuszczak, Wasilewski, Plachta, Absent were: Brs. Haszlakiewicz, Kozelka, and Kurdziel. Br. Konopka declared a quorum.

Minutes of the previous meeting. Br. Grzadziel moved to dispense of the reading of the minutes of the previous Board meeting and to accept them as presented. Br. Dykas seconded. Motion passed.

Correspondence: Br. Ciesla informed about a letter that was received from the Dziennik Zwiazkowy informing about Chicago Society Easter wishes. The deadline for accepting our greetings is set for March 19, 2021. Cost of a business size greeting is \$70. Br. Konopka recommended that Br. Plachta will send the check for \$70 with the Chicago Society Easter wishes to Dziennik Zwiazkowy. Br. Matuszczak moved to accept the payment. Br. Ciesla seconded. Motion passed. The second letter was from the U.S. Census Bureau 2020. It is a thank you letter for the Chicago Society partnership in helping to achieve a successful 2020 Census. Br. Matuszczak moved to send the letter to our files. Br. Ciesla seconded. Motion passed. Additionally, there was a letter from the State of Illinois Department of Revenue, denying our sales tax exemption application. Br. Konopka recommended to discuss this issue with the past Treasurer Ric Wiermanski or with Mariusz Folta of the TaxPol Co.

<u>Bills:</u> Br. Matuszczak moved to pay the bill of \$125.65 from System Forms, Inc., for printing and mailing of the February Forum. Br. Konopka seconded. Motion passed. We still didn't receive an invoice for printing of January 2021 Forum.

Directors and Officers Reports:

 1^{st} Vice-President: Br. Grzadziel reported that he was in contact with potential speakers for when we will restart in person meetings. Br. Matuszczak moved to accept to accept the report. Br. Kogut seconded. Motion passed.

2nd Vice-President: Br. Cwiakala stated that some organizations are planning meeting in person for May 2021. He also is looking for a place where we could meet in person in May, depending what the City will do in the near future. We will decide at our April Board meeting. Br. Matuszczak moved to accept the report. Br. Kogut seconded. Motion passed.

Financial Secretary: Br. Ciesla reported that our total deposits to date are \$9,085.24. The Wiecek repayments are on schedule and has a balance of \$5,416.04 (24+more payments). We have 101 members; which includes 3 members with waived dues. Seventy-five members have paid their dues for 2021. One applicant is to be inducted. Second notices to the members who have not paid their dues by February 1st were mailed on February 2, 2021 as regular first-class mail. List of theses members will be available for Board members to contact them individually to encourage them and pay the dues. Additionally, there were some changes to electronical addresses and phone numbers of some of our members. The list of members that still didn't pay their dues will be also published in the March issue of Forum. Br. Dykas moved to accept the report. Br. Wasilewski seconded. Motion passed.

<u>Treasurer:</u> Br. Plachta stated that he send electronically the Treasurer report to the Board members. There were no comments. He added that a \$10 fee has been charged to our savings account at the PSFCU as a Membership Fee. Br. Cwiakala moved to accept the report. Br. Grzadziel seconded. Motion passed.



Advocate: Br. Wasilewski reported that there is some delay with the Wiecek payments. He had this problem in February, but PayPal finally received confirmation from his new bank account and transferred the money to us. We will need to wait for a few weeks to see if the payment will go thru. Br. Matuszczak moved to accept the report. Br. Dykas seconded. Motion passed.

Social Activities Director: Br. Kurdziel was absent. There was no report.

Director of Outreach: Br. Matuszczak informed that most probably there will be no 3rd May Parade this year and consequently there will be no Pre-Parade Brunch. Br. Piecewicz will need to decide how he will hand out the Chicago Society Foundation Scholarships. When we will meet again in person, we will need to look for a possibility of a Youth Camp. There may be a need for larger amount of money about \$2000 or \$3000. We could get it from the Chicago Society Foundation but their next meeting is end of March and a written request has to be send to them pretty soon. Br. Dykas raised a motion to approve a \$1000 expenditure for a "Pisanki" (Easter Eggs decoration competition) that is organized by the Polish Museum of America. Br. Dykas will confirm if this will be scheduled. We should also get a letter for such a request, written document that will be needed for our records. Br. Ciesla moved to accept the request. Br. Dykas seconded. Motion passed.

<u>Director of Publications:</u> Br. Kozelka was absent and there was no report.

<u>Director of Personnel:</u> Br. Kogut reported that the Audit Report has been submitted. Copies have been sent to Board members for their review and comments to be discussed during the next April Board meeting. He also informed that there is an individual from last year that plans to join the Chicago Society. He will be introduced at our first in person meeting. Br. Kogut mentioned that he has passed list of the birthdays and anniversaries on to the director of publications to put in the Forum. Br. Ciesla moved to accept the report. Br. Matuszczak seconded. Motion passed.

<u>Social Media Committee:</u> Br. Dykas recommended a Chicago Society face-book page for the organization and a separate one for members only. Br. Laskowski has been recommended to join the Social Media Committee. Br. Matuszczak moved to accept this recommendation. Br. Dykas seconded. Motion passed.

<u>Custodial Committee</u>: Members are Br. Matuszczak, Br. Ciesla and Br. Wasilewski. This Committee needs a Chairperson. Br. Wasilewski was recommended as the Chair. Br. Dykas moved to accept the recommendation. Br.Kogut seconded. Motion passed.



Old Business: There were requests for printed directory. There is a concern that as soon as one is printed then it's out of date. The current one needs to be updated. Spreadsheet is needed with members birthdays and their anniversaries. We need a new St. Joseph. Any volunteers?

<u>Good of the Order:</u> Br. Matuszczak observed that Br. Kurdziel missed some meetings lately. He could give up his office or be suspended. Br. Konopka said that he will discuss this with him.

Adjournment: Motion to adjourn was made by Br. Matuszczak and was seconded by Br.Ciesla. There being no other business, Br. Konopka adjourned the meeting at 8:10 pm.

Casimir Pulaski: Polish & American Hero

Kazimierz Michał Władysław Wiktor Pułaski of Ślepowron (March 4 or March 6, 1745 – October 11, 1779) was a Polish nobleman, soldier and military commander who has been called, together with his counterpart Michael Kovats de Fabriczy, "the father of the American cavalry."

Born in Warsaw and following in his father's footsteps, he became interested in politics at an early age. He soon became involved in the mil-

itary and in revolutionary affairs in the Polish–Lithuanian Commonwealth. Pulaski was one of the leading military commanders for the Bar Confederation and fought against the Commonwealth's Russian domination. When this uprising failed, he was driven into exile. Following a recommendation by Benjamin Franklin, Pulaski traveled to North America to help in the American Revolutionary War. He distinguished himself throughout the



revolution, most notably when he saved the life of George Washington. Pulaski became a general in the Continental Army, and he and his friend, Michael Kovats, created the Pulaski Cavalry Legion and reformed the American cavalry as a whole. At the Battle of Savannah, while leading a cavalry charge against British forces, he was fatally wounded by grapeshot and died shortly after.

Pulaski is remembered as a hero who fought for independence and freedom in Poland and the United States. Numerous places and events are named in his honor, and he is commemorated by many works of art. Pulaski is one of only eight people to be awarded honorary United States citizenship.
