## **Chicago Society Early History: Lodge 1450**

#### Founding:

The idea of founding the Chicago Society of the Polish National Alliance was conceived by Messrs. Leo S. Mallek, Frank A. Osuch and Alexander M. Smietanka. The preliminary organization was effected at the Western Hall on April 1, 1912 and the Charter incorporating the Society was granted by the State of Illinois an May 2, 1912: the franchise admitting it into the Polish National Alliance as Group 1450 was received on the same day.

Others who participated in the founding are Casimir Adamowski, Charles Brozowski, Leon W. Dyniewicz, Matthew J. Dynowicz, F. Phil Garbark, John Konczyk,

Urbanski, Stephen Wieckowski, John W. Wisniewski, Adalbert L. Balassa, Frank Baranik, Edward Dombrowski, Maximilian Gorny, Leon F. Jareczek, Sylvester Klosowski, Anthony A. Kowalski, Victor Parazinski and Frank Rogalski.

#### **Objectives:**

The founders proposed the objectives of Pol-American Organizational effort as two-fold: First, service related to causes cherished by the early settlers and pioneers of social activity among the Poles in America, i.e. service to Poles as Poles;

Secondly, service related to the problems confronting the progeny of these early settlers and pioneers reared in the atmosphere of America, educated in its institutions and constituting an integral part of American citizenship.

Services related to the first objective consisted of participation in existing national organizations, support of their idealistic aims and intro-organizational correlation and coordination of activities predicated on service to charity, education and welfare, as exemplified by the founding of the Polish Day Association and the Polish Welfare Association (now called Polish American Association).

Services related to the second objective follows three main areas of activity: (1) cultivation and promotion of good will in the American community by acquainting it with the historical and cultural Backgrounds of the Polish people, the contributions made by the Pol-American segment to the economic and social welfare of America; (2) gaining due recognition and representation in the official life of America by participating in all civic endeavors, contributing to the civic thought of the community, and cooperating in all sociological efforts; (3) training and developing alert leadership to carry on and guide future efforts by establishing protectorate over the under-privileged youth, granting subsidies for talented scholars and artists, and encouraging a common front in all matters affecting American citizens of Polish nativity or descent.

Inspired by the hope of accomplishing the foregoing purposes, the professional and businessmen of Polish extraction united in the Chicago Society by bonds of fellowship and common objectives have caused it to become a power for good and a symbol of service in the community.

# Chicago Society, P.N.A. Minutes of the General Membership Meeting Held on Wednesday, January 20, 2021 Due to the corona virus emergency this was a ZOOM meeting



<u>Call to Order</u>: President Brother Konopka called the meeting to order at 7:00 pm.

- Roll Call of Officers and Directors present: Brs., Konopka, Grzadziel, Cwiakala, Haszlakiewicz, Ciesla, Plachta, Wasilewski, Dykas, Kurdziel, Kogut, Kozelka, Matuszczak. All board members present.
- <u>Chicago Society Pledge and Prayer</u>: Br. Matuszczak conducted the Pledge to the Allegiance ceremony. Br. Haszlakiewicz, the designated St. Joseph, recited the Prayer of St. Francis of Assisi
- <u>Minutes of the Previous Meeting:</u> Minutes of the previous Board and General meetings were provided in the latest Forum edition. Motion by Br. Matuszczak to dispense of the reading of the meeting minutes and approve them as presented was seconded by Br. Dykas. Motion passed.

#### **Directors and Officers Reports:**

- 1st Vice-President: Br. Grzadziel stated that securing speakers for our present ZOOM format meetings would be difficult and that he is exploring other options which, after conferring with the president, he will share with the membership. Motion to accept report made by Br. Gondela and seconded by Br. Kogut. Motion passed.
- 2<sup>nd</sup> Vice-President: Br. Cwiakala is exploring meeting venues for when in person meetings return and asked for help from our brothers. He said he would like to avoid using Sawa's. Suggestion was made to use Great Escape on Irving Park which Br. Cwiakala said was already "in his basket". Motion to accept report made by Br. Ciesla and seconded by Br. Kurdziel. Motion passed.
- <u>Secretary:</u> Br. Haszlakiewicz will continue to accept any and all Chicago Society documentation electronically or otherwise. He offered to pick up any paper documents from member brothers and scan them into computer files to be archived. Question was raised whether Chicago Society Foundation should also digitize their documents. Br. Makarewicz asked to table this issue to a future meeting. Br. Konopka explained that the new "Document retention policy" (which is published in it's entirety in the Forum) is intended to safeguard all Society documents from loss and to be managed by the secretary. Motion to accept report made by Br. Makarewicz and seconded by Br. Matuszczak. Motion passed.
- <u>Financial Secretary</u>: Br. Ciesla said that nearly 45% of members have paid their dues and that he will send out another notice before Feb. 1 to remind everyone that dues are due by March 1<sup>st</sup>. Motion to accept report made by Br. Gondela and seconded by Br. Kogut. Motion passed.
- <u>Treasurer:</u> Br. Plachta confirmed that he sent documentation to Br. Kogut for the Audit committee and to Br. Haszlakiewicz for archiving. Br. Matuszczak moved to accept the report and Br. Ciesla seconded. Motion passed.
- <u>Advocate:</u> Br. Ed Wasilewski reported that Ted Wieczek continues to make timely agreed on payments and that any changes to the agreement will be brought forth. Motion to accept report made by Br. Cwiakala, seconded by Br. Makarewicz. Motion passed.
- <u>Senior Director:</u> Br. Dykas no report. Enjoying his "retirement" from the presidency.
- <u>Director of Social Activities</u>: Br. Kurdziel had nothing to report, however, Br. Konopka added that the golf outing at Glen Eagle on July 9 has been secured and planning is moving forward while hoping the pandemic crisis will be behind us by then. This will be our first event for the year and Br. Konopka asked for "all hands on deck" to make it a success. Brs. Makarewicz, Wiermanski and Nowak have already volunteered to help. Br. Dykas thanked everyone who came out in support of the Deserving Children

Christmas Party which was held in the PNA parking lot as a drive-by event. Specifically, lunch from Costco, treats and cookies from Lowell Int. Foods, sodas provided by Polish Scouts, and Santa Claus. There were about 66 participating children from various organizations and the monetary donations exceeded what was spent, so there's money left over for next Christmas. Br. Ciesla asked about the plans for May 3 brunch/parade. Br. Matuszczak explained that after talking with Jan Kopec, Director of the May 3 parade committee, that it's unlikely that there will be a parade this year. Motion to accept report made by Br. Ciesla and seconded by Br. Przybylski. Motion passed. Director of Outreach: Br. Matuszczak reported that it's been difficult getting out to see people due to the pandemic and he's hoping to do some youth activities by July or August. Even though we missed the deadline, The Polish & Slavic Credit Union accepted our \$300 donation to three schools in Poland which came out of our Youth Fund. Br. Konopka added that we were invited by the Credit Union to donate to Youth Hospices in Poland which resulted with \$100 being donated to three different hospices through efforts by Brs. Matuszczak and Ciesla. Br. Cwiakala suggested we pay for one or two children to attend the PNA Youth Camp in Yorkville. (This was not addressed further at this time.) Motion to accept report made by Br. Ciesla and seconded by Br. Piecewicz. Motion passed.

<u>Director of Personnel</u>: Br. Kogut confirmed that he sent to the newly selected Audit Committee all pertinent financial documents for 2020 as well as a copy of the previous years' audit report and directions on how to proceed. Br. Kogut acknowledged that he is the liaison to the committee and Br. Michalak its' chairman. The emails sent to the audit committee were also copied to Brs., Ciesla and Plachta and Br. Wiermanski can always be called on to assist. Br. Kogut directed Br. Michalak to have the report ready by March 1, 2021. Br. Kogut explained that Br. Michalak is an attorney and an accountant who he has known for over 30 years and has full confidence as chair of the committee. There are no personnel issues at this time. Br. Cwiakala offered to get together with Br. Kogut to help with the transition. Motion to accept report made by Br. Kurdziel and seconded by Br. Dykas. Motion passed.

<u>Director of Publications</u>: Br. Kozelka asked for articles and news worthy items which could be published in our Forum. Motion to accept report made by Br. Matuszczak and seconded by Br. Kogut. Motion passed.

New Business: Br. Kozelka suggested the Forum include a "networking" section for employment opportunities and job seekers – like a two way help wanted. It was deemed to be a good idea.

Good of the Order: Br. Konopka urged everybody to stay safe and healthy.

Adjournment: Motion to adjourn was made by Br. Matuszczak. Br. Przybylski seconded. There being no farther business Br. Konopka adjourned the meeting at 7:32 pm.

## **Passing Notice: Brother Francis Gembala**



## 18th Century: Zenith of the Polish-Lithuanian Commonwealth



The Commonwealth was able to sustain the levels of prosperity achieved during the Jagiellonian period, while its political system matured as a unique noble democracy with an elective monarchy. From the mid-17th century, however, the huge state entered a period of decline caused by devastating wars and the deterioration of its political system. Significant internal reforms were introduced in the late 18th century, such as Europe's first Constitution of 3 May 1791, but neighboring powers did not allow the reforms to advance. The existence of the Commonwealth ended in 1795 after a series of invasions and partitions of Polish territory carried out by the Russian Empire in the east, the Kingdom of Prussia in the west and the Habsburg Monarchy in the south. From 1795 until 1918, no truly independent Polish state existed, although strong Polish resistance movements operated. The opportunity to regain sovereignty only materialized after World War I, when the three partitioning imperial powers were fatally weakened in the wake of war and revolution.
