Chicago Society, P.N.A. Minutes of the Board of Directors Meeting Held on Monday January 4, 2021 Due to the corona virus emergency this was a ZOOM meeting



Call to Order: President Dykas called the meeting to order at 7:05 pm.

Roll Call of Officers and Directors present: Brs. Ciesla, Cwiakala, Dykas, Kawalkowski, Konopka, Kozielka, Kurdziel, Matuszczak, Mikoda. Plachta, Wiermanski. Absent was: Br. Piecewicz. Br. Dykas declared a quorum.

Bills: Br. Matuszczak moved to pay the bill of \$125.65 from System Forms, Inc., for printing and mailing of the December Forum. Additional bill for \$100.47 to Br. Ciesla as a reimbursement for the mailing of dues notices. Br. Konopka seconded. Motion passed.

Correspondence: Br. Ciesla informed about a letter with Christmas Greetings and request for a donation that was received from the Polish Museum of America. Polish & Slavic Federal Credit Union is informing us that they are raising funds for three children care facilities in Poland. Br. Matuszczak moved to donate \$300. Br. Cwiakala seconded. Motion passed.

Directors and Officers Reports:

1st Vice-President: Br. Konopka had nothing to report, we didn't have any speakers. Br. Matuszczak moved to accept to accept the report. Br. Ciesla seconded. Motion passed.

2nd Vice-President: Br. Matuszczak stated that we didn't have any meetings, had nothing to report. Br. Konopka moved to accept the report. Br. Kurdziel seconded. Motion passed.

Financial Secretary: Br. Ciesla reported that our total balance to date is: (redacted) The Wiecek repayments are on schedule and has a balance of (redacted) (26+more payments). We have 102 members; which includes 3 members with waived dues. One applicant is to be inducted. Dues invoices for 2021 have been mailed. 40 members have already paid their dues. In February a reminder will be mailed. There are four email addresses that have been changed or corrected: Frank Gembala, Chris Grzadziel, Andrew Haszlakiewicz and William Marutzky. Br. Matuszczak moved to accept the report. Br. Kurdziel seconded. Motion passed.

Treasurer: Br. Wiermanski stated that last week he sent his report to the Board members. There were no comments. Br. Wiermanski stated that this year we have about \$8,000 surplus due to the pandemic environment and lack of face to face Society meetings. Tax forms for 2020 will be prepared by Mariusz Folta from the Taxpol Corporation. In the next few days Br. Wiermanski will mail all the Treasurer documents to Br.Plachta who will be the CS Treasurer for 2021. The documents are ready for the audit. Budget for 2021 has been prepared with input from Br. Konopka and Br. Ciesla. The assumptions are, that the General meetings will resume in October. Events will resume in late summer with a picnic and a golf outing. Br. Dykas thanked Br. Wiermanski for the outstanding job he did as a Treasurer. The names of Br. Plachta and Br. Grzadziel have been added to the signature cards at the Polish & Slavic Federal Credit Union office at the Mt. Prospect Branch location. Br. Ciesla moved to accept the report. Br. Kawalkowski seconded. Motion passed.

Advocate: Br. Piecewicz was absent, there was no report.

Director of Publications: Br. Kozelka stated that overall cost of Forum publication for the year was nearly \$1400. Average opening of the Forum via email was 64%, about 2/3 of recipients read the Forum electronically. He questioned if we should continue to publish hardcopies of Forum. Br. Matuszczak moved to accept the report. Br. Ciesla seconded. Motion passed.

Director of Outreach: Br. Kurdziel didn't have a report this time. Br. Matuszczak moved to accept the report. Br. Mikoda seconded. Motion passed.

Social Activities Director: Br. Kawalkowski didn't have much to report. He congratulated Br. Dykas for a successful Deserving Children's Christmas Party. There were 66 children in attendance. Total donations were \$1010.62. Polish Slavic Fedderal Credit Union donated \$300, Dee Blicharski donated \$300, Kasia & Chris Grzadziel donated \$200. John Wasilewski and Ted Kozelka donated \$50 each, Ray Golenia and Zenon Kurdzial donated \$20 each. Thomas Jaconetty donated \$75. There were also

donations from Lowells Int. Foods, potato chips and Polish Scouts donated soda. Total expenses for LCD writing tablets, hot dogs, gifts for volunteers and supplies were \$782.26. The Golf Outing is scheduled for July 9, at Glen Eagles Golf Course. Adam Konopka stated that we need volunteers and sponsors to achieve a success. Deposit of \$500 is needed now. Br. Matuszczak moved to approve this expenditure. Br. Ciesla seconded. Motion passed. Br. Kurdziel volunteered to be chairman of the Pre-Parade Brunch. It is still undecided if we will have a May 3rd Parade. Br. Matuszczak volunteered to find out what's the status of the Parade.

Br. Kurdziel moved to accept Br. Kawalkowski report. Br. Mikoda seconded. Motion passed.

Old Business: Br. Konopka informed about our Document Retention Policy. The documents of the Society will be kept electronically by the Secretary and be available for use or inspection upon request of the President or the Board of Directors. The Secretary shall retain, for seven (7) years, any documents received or generated by the Society related to their meetings, events or activities on a month to month basis in an electronic folder. Such documents include, but are not limited to meeting minutes, receipts, contracts, correspondence (ingoing and outgoing), event reports, reimbursement requests, tax returns, applications for membership, invoices, officer and director reports, insurance policies and audit reports. Any Society member, be it Board Member, Officer, Director, event organizer, auditor, committee member or otherwise shall provide the Secretary with an electronic copy of the aforementioned within 30 days of receipt or generation. Any documents required by law or directed by the Board of Directors to be maintained via hard copy shall be kept by the Secretary in paper form and available for use or inspection by the Society upon request of the President or the Board of Directors. With the exception of corporate documents and any documents directed by the Board of Directors to be maintained perpetually by the Society, all Society documents more than seven (7) years old shall be destroyed and/or deleted. Any Society member, past or present, in the custody of Society documents in any form, shall inform the Secretary of their existence. The Secretary will then retain or destroy the documents in accordance with this policy. Outgoing Society Officers, Directors, Board Members, event organizers, auditors, committee members shall provide any documents to their successors and the Secretary in electronic form and destroy any other copies.Br. Mikoda moved to accept the report. Br. Ciesla seconded. Motion passed.

Director of Personnel: Br. Cwiakala reported that there are no new applicants. One applicant is to be inducted. Br. Matuszczak moved to accept the report. Br. Kozelka seconded. Motion passed.

Good of the Order: Br. Konopka stated that there are several Chicago Society items that are kept in storage be several Chicago Society members. He recommended that a spread sheet be prepared with information about these items and where are they stored.

New Board of Directors: The out-going Board of Directors was given a thank you for their services and Br. Wiermanski administered the oath of office to the new Board of Directors. Br. Konopka as 2021 President continued the meeting.

This Month in Polish History—The January Uprising

The January Uprising (powstanie styczniowe) was an insurrection principally in Russia's Kingdom of Poland aimed at the restoration of the Polish–Lithuanian Commonwealth. It began on 22 January 1863 and continued until the last insurgents were captured by the Russian forces in 1864. It was the longest lasting insurgency in post-partition Poland. The conflict engaged all levels of society, and arguably had repercussions on contemporary international relations and ultimately provoked a social and ideological paradigm shift in national events that went on to have a decisive influence on the subsequent development of Polish society.

It was the confluence of a number of factors that rendered the uprising inevitable in early 1863. The Polish nobility and urban bourgeois circles longed for the semi-autonomous status they had enjoyed in Congress Poland before the previous insurgency, a generation earlier in 1830, while youth encouraged by the success of the Italian independence movement urgently desired the same outcome. Russia had been weakened by its Crimean adventure and had introduced a more liberal attitude in its internal politics which encouraged Poland's underground National Government to plan an organized strike against their Russian occupiers no earlier than the Spring of 1863.

They had not reckoned with Aleksander Wielopolski, the pro-Russian arch-conservative head of the civil administration in the Russian partition, who got wind of the plans. Wielopolski was aware that his fellow countrymen's fervent desire for independence was coming to a head, something he wanted to avoid at all costs. In an attempt to derail the Polish national movement, he brought forward to January the conscription of young Polish activists into the Imperial Russian Army (for 20-year service). That decision is what triggered the January Uprising of 1863, the very outcome Wielopolski had wanted to avoid.

The rebellion by young Polish conscripts was soon joined by high-ranking Polish-Lithuanian officers and members of the political class. The insurrectionists, as yet ill-organized, were severely outnumbered and lacking sufficient foreign support, and were forced into hazardous guerrilla tactics. Reprisals were swift and ruthless. Public executions and deportations to Siberia eventually persuaded many Poles to abandon armed struggle. In addition, Tsar Alexander II hit the landed gentry hard, and as a result the whole economy, with a sudden decision in 1864 to finally abolish serfdom in Poland. The ensuing break-up of estates and destitution of many peasants convinced educated Poles to turn instead to the idea of "organic work", economic and cultural self-improvement.


The 2021 Golf Outing is Coming!

Tasting Room

We'll kick of 2021 with a review of the delightful Kentucky bourbon I received as a gift from my brother-in-law. This bottle hits well above it's weight with a light start and complicated aftertaste. You can find Longbranch at your local fine spirits vendor for typically less than \$40, which is a steal in the Bourbon world.

Matthew McConaughey (the actor) and Master Distiller Eddie Russell are proud to present this rare, small-batch bourbon. Eight Year-Old Wild Turkey Bourbon is refined with Texas mesquite and oak charcoals for deeper flavor and complexity.

The aroma is a balanced blend of vanilla and spices. Flavors of caramel, pear, and hints of citrus round out the palate, while the subtle, smoky finish is buttery smooth—with notes of gentle pepper and toasted oak.

For anyone who is a fan of the Wild Turkey brand's flavor profile, Longbranch is more of the same yet slightly tweaked. In the end Longbranch might not blow you away but it offers just enough to keep it from being just another new bourbon on the market. It will be interesting to see if this release connects with bourbon drinkers and if it will become a permanent expression for the company. Wild Turkey may not have reinvented the wheel here but there's enough to justify its place on the shelf.
