#### HISTORIC MANOR RESTORED

Following an extensive conversion project aided by EU funds, a historic house that belonged to one of Poland's most prolific artistic dynasties has been voted one of the "Wonders of Poland." The manor, which burned to the ground in 1945, belonged to Zofia Kossak, a celebrated author and co-founder of Zegota, Poland's wartime Council to Aid Jews. The house, located in the village of Gorki Wielkie, southwest Poland, was no more than a ruin two years ago. A state-of-the-art cultural center, free to visitors, was opened last year. (PMN)

# CHICAGO HONOR FLIGHT - BILL POWELL

Brother Bill Powell was honored on May 11, 2011, along with 97 other veterans of WW II, by Honor Flight Chicago, a program dedicated to permitting veterans of WW II to visit the memorials in Washington, D.C., all at no expense to the veterans.

Upon their arrival in the evening back at Midway Airport, the veterans were met by thousands of cheering people, all waving flags, clapping and thanking them for their service to the U.S. in defeating forces of tyranny and protecting the freedom of our citizens.

Brother Powell proudly served 5 years as an officer in the Navy, commencing December 8, 1941. He served initially in Naval intelligence combating espionage and sabotage. His next assignment was as an amphibious officer, participating in Naval operations in the European theatre in southern France. After that campaign was completed, his attack amphibious ship sailed immediately to the Pacific Ocean where Bill participated in Naval actions in the Philippine Islands, the Marshall Islands, Okinawa, Kwajalein and Eniwetok, culminating in the occupation of Japan at Wakayama.

After being mustered out of the Navy in 1946, Bill completed his interrupted law school course at De Paul University, took and passed the bar exam and began a successful law practice until his retirement in 2007.

Bill married his college sweetheart, Mildred Tomchek, in 1942 during the war. They celebrated 68 years of wedded bliss until her death on November 16, 2010. They have five children, ten grandchildren and nine great grandchildren.

Brother Powell has been an active member of the Chicago Society since 1947 and regards the Chicago Society fellowship and comradeship that he has enjoyed as highlights of his life.

#### PAC ISSUES VISA WAIVER ACTION ALERT

Chicago (PMN)—In March, 2011, sympathetic Members of the U.S. Congress introduced legislation in both chambers to revise requirements for the Visa Waiver Program (VWP). It would make travel by Poles to the Unites States possible without visas, as is the case with many of the allies of the U.S.

Polish American Congress (PAC) President Frank J. Spula and Executive Committee members of the PAC recently spent two days in Washington meeting with Members of Congress and Administration officials, seeking their active support for bringing Poland into the VWP.

A strong push to generate grassroots support to extend the visa waiver program to Poland was made at the meeting of the National PAC Directors in Chicago, Illinois, on May 13, 2011. It was emphasized that Polonia must do its part to encourage Representatives in both Houses of Congress to join in co-sponsoring the legislation and supporting it with their colleagues.

"A massive and loud appeal is needed to convince them our votes are at stake. Let them know we are their voting constituents and they need to pay attention to our needs," stated Spula.

Polonians and their friends can sign a Petition circulated via the internet by the PAC to help urge all U.S. Senators and U.S. Representatives to support this legislation.

Andrew A. Golko, October 1945 to May 2011. He was born in Weston-Super-Mare (United Kingdom) and came to America in 1951 with his parents Jerzy and Zdzislawa (Inglot). He served with the U.S. Army, E-5, 1965-68, receiving a commendation medal. His education consisted of a Bachelor of Science (B.S.) in finance, University of Illinois, 1971, and Juris Doctor (J.D.), John Marshall Law School, 1975, Chicago. He was an attorney in private practice and a real estate broker in offices on the far and mid north sides since 1975 and lived in a fashionable home on Logan Boulevard. He was a director of the North Side Real Estate Board, a member of the Polish National Alliance, chairman and director of the Polish American Economic Forum in 1990-91, American Bar Association, Illinois Bar Association, Chicago Bar Association, National Advocates Society and Chicago Advocates Society. He was fluent in English, Polish and German. His hobbies were skiing, tennis, and karate. In his youth he had been a member of the Floor Committee of the Legion of Young Polish Women's White and Red Ball and frequented the Chicago Intercollegiate Council. Condolences are offered to his widow Urszula (Jablonska), his daughters Caroline Golko and Ania Budaj, his brother John (Christine) Golko, and relatives Maggie, Barbara, and Hanna Piech and Eva Inglot.

Upon the death of Theodore C. Compall, M.D., age 89, condolences are extended to his widow Lillian Jane and to his children Thad, Tom and John and their seven grandchildren, and to his brothers Mark and John. Dr. Compall was a member for over a decade and had terminated his membership within the past three years due to advancing age. He was a graduate of Loyola University in Chicago and a 1947 graduate of Loyola University Stritch School of Medicine. He served in the U.S. Army and Air Force and practiced surgery for over 50 years at St. Mary of Nazareth Hospital and Holy Family Hospital, the latter where he was a founding physician.
