### In Memoriam

Brother William H. Powell, age 94, beloved husband of the late Mildred nee Tomchek, loving father of Janet M. (the late Richard) Griesenauer, William P., Thomas J., James L. (Kathy) and Mary Grace, cherished grandfather of Bill (Lisa), Jeffrey (Kelly), Daniel (Joan), Michael, Donna, Autumn Malia, Parker, Erin, Stephanie (Aleks), Jacqueline and great-grandfather of Diane, Michael, Katie, Bradley, Ryan, Cara, Danielle, Justine, Ryne and Astrid. Passed away this past December.

Brother William 'Bill' Powell was a proud veteran of the US Navy during WWII from 1941-1945. He was the oldest and longest active member of the Chicago Society until his death, and a member of the Advocates Society.

Brother Bill truly enjoyed the camaraderie and friendships that he shared over many years with the Chicago Society brothers. Brother Bill enjoyed attending social events like Brother Ro and Chris Matuszczak's annual 4<sup>th</sup> of July party with his lovely daughter Mary.

### In Memoriam

Brother Kazimer "Kaz" Swierz, age 94, passed away on Saturday, December 28<sup>th</sup>, 2013.

Kaz, as he was called by family and friends, began life in Tarnów, Poland, but the years that followed would take him across the globe. At the outset of World War II, Kaz and his family faced forced deportation to the USSR. Those that survived the journey were placed into a Soviet labor camp in Kazakhstan. In 1943, after the German invasion of the USSR, Kaz joined the newly formed Polish II Corps. The newly created Polish unit was attached to the British 8<sup>th</sup> Army and started Kaz on a journey that stretched across four continents and 17 countries. Traveling through the Middle East, Africa, Southern Europe, and eventually to Britain, Kaz took part in a number of Allied operations, most notably the campaign in Italy where he saw action at the Battle of Monte Cassino. At the conclusion of the war, Kaz spent four years in Britain in the reserves before immigrating to the United States in 1950.

Once in the United States, Kaz, who trained in Poland to become a tailor before the war broke, returned to his chosen profession. He became a partner in Dukart Clothing, Ltd., before working for the House of Duro and then Syd Jerome.

He married his wife Eleanor in 1951, and started his family before moving to Arlington Heights.

Kaz was an active member of the Chicago Society of the PNA, and proud to be a long-standing member.

He was preceded in death by his wife Eleanor (nee Gargula); survived by his children Walter Swierz, and Phyllis (Michael) Carlstrom; his grandchildren Matthew (Kelly) Carlstrom, Amanda Carlstrom, and Kristin (Paul) Lucas; and his great granddaughter Eleanor Carlstrom.
