2015 ELECTION OF OFFICERS AND DIRECTORS

The Nominating Committee for the Chicago Society of the PNA's election of 2015 officers and directors has been appointed. The Nominating Committee is composed of: Brothers Chairman **Stan Jendzejec, Ray Golenia, Joe Hercik, Tom Pawelko** and **Stanley Sawa**.

If anyone is interested in running for a position on the board, either as an officer or director-at-large, please contact the Chairman or another member of the nominating committee to find out the procedure and qualifications. You must contact them as soon as possible because the slate will be announced at the October meeting.

Rules for Voting and Running For Office if not Slated

The Nominating Committee shall select at least one candidate for each elective position who shall be required to sign an acceptance of nomination. At the October meeting, the chairman of the Nominating Committee will announce the slate of candidates that has been selected. Any member may run against a slated candidate for a particular office. The rules and procedures for doing such are stated in the Constitution, Article VII: Election of Officers and Directors.

At the regular meeting in October the Nominating Committee shall accept for nomination such additional lists of candidates for the respective offices as may be submitted by the petitions of ten or more members, provided however that the signed acceptance of each candidate is attached to each such petition. adjournment of the meeting shall close the nominations in the absence of a motion for that purpose. Immediately thereafter, the nominating committee shall submit a list containing all of the names of the candidates to the Recording Secretary who shall cause the publicizing of such list to all members in good standing at least ten days prior to the date of the November election meeting.

The President shall appoint five Judges of Election, if necessary, who shall prepare a ballot, have charge of the polls of election, canvass the votes and certify the results to the Recording Secretary. Only members in good standing shall be eligible to be elected, to sign petitions or to vote. No member admitted to membership in the Society within five days of election shall be eligible to vote at the election.

Chicago (PMN)—The Executive Committee and the Board of Directors of The Polish Museum of America (PMA) formally announced the selection of the new Managing Director, Malgorzata Kot, on July 25, 2014. After an intense search and interview process, Kot was chosen from a field of qualified candidates.

Kot assumes her new position on September 1, 2014.





News Briefs

Polish Prime Minister Donald Tusk said on July 25, 2014, that Poland will probably appeal against a European Court of Human Rights ruling that Poland hosted a secret CIA jail. "We're analyzing materials and it is quite probable that we will appeal against this ruling," Tusk said.

According to statistics published in *L'Osservatore Romano*, the Vatican newspaper, and repeated by *Catholic World News* on July 24, 2014, Sunday Mass attendance has fallen below 40% in Poland. Nevertheless, the nation has more seminarians than any other in Europe. According to the report 39.1% of the baptized now attend Mass on Sunday, down from 57% in the 1980s and 50% in the 1990s. The number of diocesan and religious priests in Poland continues to rise as ordinations outpace deaths. Vocations to women's religious communities, however, have lagged, and the number of women religious in Poland fell by 284 in 2012.

Estimates from the Labor Ministry indicated on July 9, 2014, that Poland's unemployment in June was the lowest in two years. The jobless rate fell to 12.1% from 12.5% in May. That was the lowest since 2012, the Ministry said.

Soldiers with the Illinois National Guard's 108th Sustainment Brigade and Polish diplomats have marked the 21year anniversary of military cooperation. A statement from the National Guard on July 23, 2014, said that the sides celebrated with recent events at a U.S. camp and the Polish Embassy in Kuwait. One of the events was an American-style barbeque. The Illinois contingent was paired with Poland in 1993 in the Defense Department's State Partnership Program. One reason the Illinois force was matched with Polish soldiers was the large number of state residents who are of Polish heritage. The contingents have deployed together in conflict areas.
