Wednesday, March 16— General Meeting Copernicus Center, Chicago This year's annual Chicago Society *Sledz* will traditionally take place at La Villa Restaurant & Banquets, 3632 North Pulaski Road, in Chicago on Tuesday, March 8, 2011. Free parking is available in lots located just north and south of the building. The venue has recently been featured, and highly rated, in the Check, Please! program on WTTW.

The celebration will start with a social hour (cash bar) at 6:00 p.m. followed by a fine dinner of various entrée choices at 7:00 p.m. This wonderful event is open to members, non-members, family relatives, singles, and guests. The cost of the event is only \$35.00 per person. There will be a raffle and a time for dancing to the music of a live band. Dinner will start with *sledz* (herring) as an appetizer. There are three choices of entrées (salmon, veal parmesan, chicken marsala) being offered. For dessert *paczki* and ice cream will be served. A fine selection of vegetables and soup will top the menu.

After dinner, the pageant of a parade representing *Sledz* will be held followed by the crowning of a St. Joseph for the year 2011. The person duly selected acts as a chaplain at the Chicago Society meetings and at special occasions leading those present in an appropriate prayer. The dress code ranges from costume through elegant semi-formal to black-tie.

The celebration of *Sledz* is the Chicago Society P.N.A. version of Christian and Polish traditions that date back centuries ago. It is a celebration of carnival. *Mardi Gras* is French for Fat Tuesday or Shrove Tuesday in ethnic English tradition. It is time of eating richer, fatty foods before the ritual fasting of the Lent season. One of the most famous places in the United States to celebrate *Mardi Gras* is New Orleans with its special parade and many colorful events.


THE PRESIDENT'S MESSAGE

Last but not least, starting in July 2011, Poland will be taking over the six-month Presidency of the European Union. This combined with the fact that the current president of the European Parliament is a Pole, Professor Jerzy Buzek (former PM of Poland), creates an unprecedented opportunity for us to demonstrate the achievements of a country that only 22 years ago was under a communist regime. MEMBER OF THE MONTH

Don was born in 1931 to Adam Gutowski and Eugenia Obal (Obalewski) in Chicago, IL. Adam was from Wojslawy, Poland and immigrated to the USA with his mother Alexandra and sister Zofia in July 1913 after the death of his father. Don's mother Eugenia was born in Chicago, IL. Don's sister Corine Agliata, who now resides in Phoenix, AZ., was in the first group of debutantes for the White and Red Ball in 1947.

Don attended five different grammar schools and graduated from Reinberg. He then graduated from Foreman HS in January 1949.

He worked in an assortment of jobs from cutting grass at St. Adalbert Cemetery, driving a truck, tool grinder, forest products (logger), records clerk, etc. He joined the USAF Reserve at O'Hare in December 1950. The Air Force trained him to be a radar Technician specializing in a unit called SHORAN (an early GPS system). Upon release from active duty in 1952 he started college at the U of I at Navy Pier. He transferred to U of I, Urbana, IL to the College of Mechanical Engineering

where he received his BSME in 1956. While he was at Urbana he received a scholarship from The American Society of Tool Engineers to work in research the Physics of Metal Cutting.

He married Lucille Remus in May 1957. They have four daughters: Deann, Laura, Ruth Eva and Mary. They all have college degrees
