Lorys. Mr. Lorys graduated from the University of Illinois at Chicago in 1971 with a BA in Political Science and MA in History, also from UIC in 1996. From 1992 till 1996, he was a bilingual teacher with CPS. He is the co-producer and writer of a film on Casimir Pulaski. Mr. Lorys served as the Director of the Polish Museum of America from June 1996 through February 2014. He played an important role as a Steering Committee member in the creation



of the Chicago Cultural Alliance, a partnership of 20 ethnic museums and cultural institutions. He has also initiated beneficial exchanges and collaborations with cultural and government institutions in Poland.

As the PMA Historian since March 2014, Mr. Lorys focuses on scholarly research, as well as updating and developing museum exhibits, including events of the Polish Museum and a movie entitled *The Fourth Partition.* Jan will speak about the importance of Polonia Events, upcoming events in Polonia, the upcoming Centennial of the Polish Army in France, and current events including the Millennium of Poland's Christianityexhibit at the Polish Museum.


CHICAGO SOCIETY ANNUAL BUSINESS EXPO IN SEPTEMBER!



3RD PLACE ESSAY — 2016 CHICAGO SOCIETY SCHOLARSHIP WINNER

What did Solidarność and the fall of communism in Poland mean to you and your family?

Being a fifth generation American (my great-great grandparents came to America in the late 1800's) Solidarity really did not have much of an impact on me or my family. Since I had no relatives living in Poland at the time.

I'm very pleased to see the fall of Communism in Poland and for the Polish people finally have the freedom for which they fought so hard for.

Salidarnosc is a Polish organization of independent trade unions founded in 1980, and was outlawed by the government in 1982. Independent of the government and of the Polish Communist Party, that grew to a membership of several million members in the early1980's, it was lead by Lech Walesa. Solidarity pushed for many reforms and played a major part in the ouster of communism in Poland and its replacement by a multiparty, democratic government. The movement had the encouragement and blessing of Pope John Paul II.

After fierce fighting for 9 years. In June 1989, in the first free elections ever in the communist bloc, Solidarity won the maximum number of seats allowed in both houses of Parliament, and with two smaller parties, it formed the first non-Communist government in the Soviet bloc.

Six months later, the Berlin Wall came crushing down.

The important lesson from the Polish phenomenon is that First, it's important to not be afraid, to see what can be done. Secondly, it's important to see the political dimension of the resistance to the authoritarian regime. One should not accept that politics is a question regarding only professional politicians. Third, it's very important to accept nonviolent philosophy. In the Solidarity period, no windows were broken during the 500 days of freedom. The violence ws only on the side of the authoritarian regime.

As Bronislaw Geremek, a key advisor to Lech Walesa said "It's important to see the implementation of this idea of the fight for bread and freedom in pragmatic terms, which means to accept that negotiation is the efficient means of actions. For starting such a negotiation process, it is important to obtain the minimum of trust from the other side. From one side and the other, it's not easy. But if you want such negotiations, it's extremely important."

Solidarity is the trade union that changed the world.


