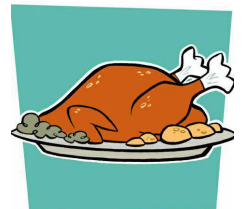

## COMM. PATLAK TO SPEAK ABOUT PROPERTY TAXES AT THE OCTOBER MEETING

Our speaker at the October General meeting will be Dan Patlak, Commissioner of the Cook County Board of Review. Mr. Patlak was sworn in as a Commissioner of the Cook County Board of Review on December 6, 2010. He is fulfilling his pledge to work as the first ever full-time commissioner at the Board.



Comm. Patlak is a Graduate of the Real Estate Institute (GRI) and has been a member of both the National and Illinois Realtors Associations for more than twenty years. As a vol-

unteer coordinator for Citizens against Government Waste from 1992 to 1994, he organized "Taxpayer Action Day Rallies" in successive years at the Kluczynski Federal Building and the Daley Plaza to draw attention to wasteful government spending. He also testified before the Cook County Board in 1992 in opposition to the original \$.75 county sales tax. Mr. Patlak was employed at the Cook County Board of Review from January 1999 to December 2006. He served as a property assessment appeal analyst for Commissioner Maureen Murphy specializing in residential, commercial apartment and exempt properties. In addition, Mr. Patlak represented the Board of Review at over 500 Illinois Property Tax Appeal Board (PTAB) oral hearings. Maureen Murphy's office conducted over 300 Property Assessment Appeal Seminars during her eight years in office; Mr. Patlak served as her surrogate speaker at more than 60 of those seminars.

Comm. Patlak will speak to us about the Board of Review as opposed to the Cook County Assessor: the differences, and the appeal processes. This will be a "hands-on" presentation; he will also have the necessary forms available and will offer guidance in filling out those forms.

## POLISH TRADITIONS IN OCTOBER

October is actually a quiet month; there are no holidays or traditional celebrations, except for *imieniny* and the occasional wedding. October, however, was a turning point in Poland under the communists—the "Fourth Partition." *Polski październik* (Polish October) marked a change in the Polish internal political scene in the second half of 1956. Some social scientists term it the Polish October Revolution, which, while less dramatic than the Hungarian Revolution of 1956, had an even deeper impact on the Eastern Bloc and on the Soviet Union's relationship to its communist satellites in Eastern Europe.

For Poland, 1956 was a year of transition. The international situation, particularly the deaths of the Soviet Union's leader, Joseph Stalin, and of Polish communist leader Bolesław Bierut, significantly weakened the hardliners' Stalinist faction in Poland. Protests in June by workers in Poznań highlighted the people's dissatisfaction with their current situation. The events set in motion resulted in the reformers' faction, led by Władysław Gomułka, taking power. After brief but tense negotiations with the Soviet Union, the Soviets gave permission for Gomułka to stay in control, and made several other concessions resulting in wider autonomy for the Polish government. For Polish citizens, this meant the temporary liberalization of life in Poland. Eventually, hopes for full liberalization were proven false, as Gomułka's regime became more oppressive; nonetheless, the era of Stalinization in Poland had ended.

Gomułka, in his public speeches, criticized the hardships of Stalinism and promised reforms to democratize the country; this was received with much enthusiasm by Polish society. By mid-November, Gomułka had secured substantive gains in his negotiations with the Soviets: the cancellation of Poland's existing debts, new preferential trade terms, abandonment of the unpopular Soviet-imposed collectivization of Polish agriculture, and permission to liberalize policy towards the Roman Catholic Church.

In the aftermath of the October events, many Soviet "advisers" left Poland, signaling that Moscow was willing to grant Polish communists slightly more independence. The Polish government rehabilitated many victims of the Stalinist era, and many political prisoners were set free. Among them was Cardinal Stefan Wyszyński. The Polish legislative election of 1957 was much more liberal than that of 1952 although still not considered free by Western standards.

**Did you know?** October in Polish is *październik*, from the word *paździerz*, meaning "waste from flax or hemp."

*Gdy październik ciepło trzyma, zwykle mroźna bywa zima.* (When October is warm, there will usually be a cold winter.)

## NEWS BRIEFS

LOT, Poland's national air carrier, has launched sales of tickets for Dreamliner flights that will be available to passengers starting in December. The first Boeing 787 Dreamliner will service flights to European capitals, in an attempt to encourage customers to take advantage of LOT's longer-haul flights. LOT is currently the only European airline operating Boeing 787 Dreamliners in its fleet. The first transatlantic flight to Chicago has been scheduled for January 2013. Toronto and New York will be added to the itinerary in February, while Beijing will be included in March.

A military bunker in Northeastern Poland, where some German army officers attempted to assassinate dictator Adolf Hitler in 1944, will be thrown open to the public as a museum. The Wolf's Lair, located in the Masurian woods in northeastern Poland, has been open to the public since the end of World War II, but mainly as a place to take pottery lessons and play paintball. The place has been under lease to a private company, Wolf's Nest, since the collapse of Poland's communist regime. The company turned bunkers into a restaurant and a hotel, cleared some tourist trails of debris, and made the bunker into an indoor shooting range. Over time, according to Jan Oldakowski, 40, a director of the popular Warsaw Uprising Museum, the Wolf's Lair became a "grotesque Disneyland."

Following a sitting of the Intergovernmental Lithuanian-Polish Commission on Economic Cooperation, Lithuanian and

Polish Ministries of Economy signed a protocol that aims at strengthening bilateral cooperation in transport, energy, trade, investment, etc. The meeting focused on cooperation in the sectors of energy and transport. The representatives of Lithuania and Poland discussed the construction of gas terminals, shale gas potential, changes in the electricity sector and the progress of Rail Baltica and Via Baltica. In the first half of 2012, Poland among all Lithuania's trade partners (184 in total) ranked 4<sup>th</sup> in terms of trade turnover (\$1.2 billion) 7<sup>th</sup> in terms of exports and 3<sup>rd</sup> in terms of imports.

Ukrainian President Viktor Yanukovich and his Polish counterpart, Bronislaw Komorowski, have unveiled a monument commemorating the victims of totalitarianism on the premises of the Bykivnia Graves National Historic-Memorial Reserve, in the Kyiv [Kiev] region. The two presidents laid flowers at the monument, the memorial sign at the Polish graves and the common grave, an Interfax-Ukraine

correspondent reported on September 21, 2012. Memories of those terrible times unite the Polish and Ukrainian people, the Ukrainian president said. Komorowski, for his part, said that Warsaw had long been looking forward to this moment. The Stalin-led regime sought to destroy both people and their memory, the Polish president said.

For the second consecutive year, Northern Essex Community College in Massachusetts had visitors from abroad attending the school for the month of September. The college hosted 14 students from the Adam Mickiewicz University in Poznan, Poland. "We thought it would be a good idea to come to the States, and immerse ourselves in the culture while learning the language," said Hanna Pluta, a law and European studies major. The students took an English class, as well as classes on American culture, geography, history and biology. They took classes in the morning and then had the rest of the day to themselves to explore the area.

As a member for nearly 30 years, and honored to be its President in 2003-04, I have many fond memories of the club and its activities over those years. I recall a pre-Constitution Day brunch where I was chatting with then Congressional candidate Rahm Emanuel and talking about some of the concerns in the Chicago Polish community, sitting at a regular meeting with then Lieutenant Governor candidate Bob Kustra, who of course is now President of the football powerhouse Boise State, and having the chance at another function to talk to the then elderly Ben Adamowski, who nearly beat the first Richard Daley for mayor (more than a few would say he really did) at a time when the Polish community was particularly strong in Chicago.

But times change and so has the Society. Decades ago I have to think that joining the Society was practically a necessity because of ethnic discrimination and the need to unify to strengthen our voice at the political and professional table. While these concerns haven't disappeared, I like to think the Society has played a role in integrating Polish-Americans into the American melting pot, joining the steam of other European ethnic groups into the suburbs, the chambers of commerce, and jobs and institutions once out of reach.

The Society continues to remain relevant, it seems to me, and is why I am a member, for cultural reasons. Pride of being Polish is important, and sharing that belief with others allows the Society to maintain the traditions, help fund worthy endeavors through our Foundation, and share common experiences like Catholic school, *Wigilia*, and the like. Although for different reasons, there should be a place for the Chicago Society over the next decades, for future generations.

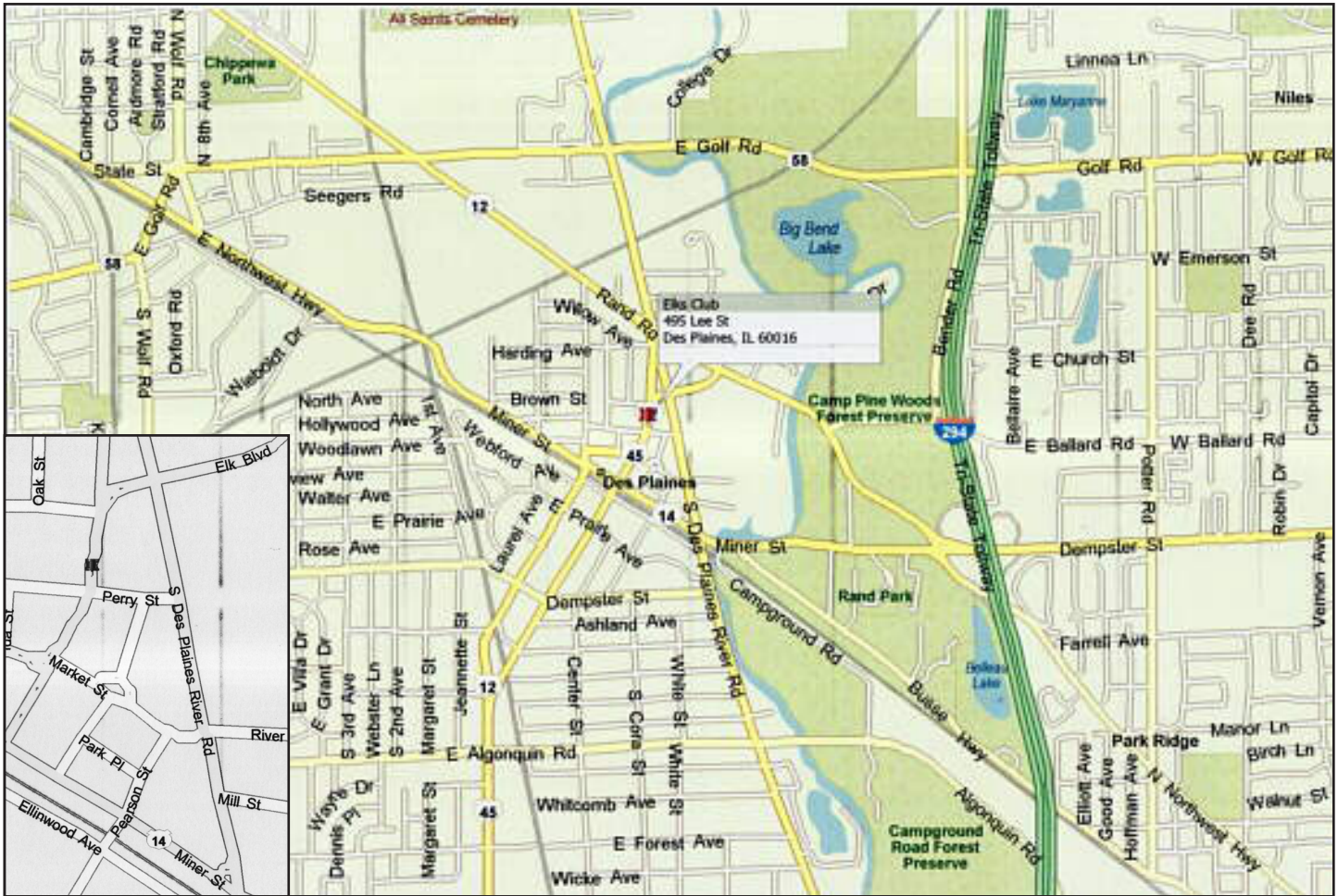

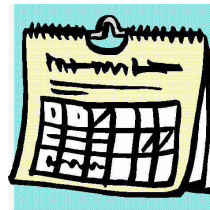
