The concept of a Table Captain at the Inaugural Ball was introduced to the membership years ago,

The Table Captain is a very important role at The Club's winter Gala; and, in reality, the benefit of using a table captain system extends to the *Sledz* (Mardi Gras), the Candidates' Corned Beef Dinner and to the Pre-Parade Brunch.
