THE CHICAGO SOCIETY'S ŚLEDŹ MARDI GRAS PARTY

This year's annual Chicago Society Śledź will take place at the White Eagle Restaurant and Banquets, 6839 North Milwaukee Avenue, Niles, IL 60714, on Tuesday, February 17, 2015. The festivities will begin with a social hour (cash bar) at 6:00 p.m. followed by a fine dinner at 7:00 p.m. of herring in cream sauce, chubs, rye bread, *biały* (white) *barszcz* soup, potatoes, *pierogi*, *kiełbasa*, *kapusta*, Polish style chicken *de volaille*, green beans *almondine*, coffee or tea, ice cream, and *pączki*. This festive event is open to members, non-members, family, relatives, singles, and guests. Dinner will start with *śledź* (herring) as an appetizer.

After dinner, the traditional pageant representing Śledź will be held followed by the crowning of St. Joseph for 2015. The gentleman selected acts as our chaplain at Chicago Society meetings and at special occasions, leading those present in an appropriate prayer. The celebration of Śledź is the Chicago Society's version of Christian and Polish traditions that date back centuries. It is a celebration of carnival, or *Mardi Gras*—the period immediately preceding Lent. Following our unique pageant will be an open bar and raffle with prizes. The cost is \$40.00 per person.

FEBRUARY MEETING SPEAKER (H2O)

Brother **Charles Komosa** has arranged for **Ms. Mariyana Spyropoulos**, President of the Metropolitan Water Reclamation District of Greater Chicago, to be our featured speaker at the February General meeting. She was appointed to her post in 2009 and was elected in 2010. She was elected as Chairman of Finance in January, 2013, and Board President in January, 2015. President Spyropoulos serves as Chairman of three committees: Judiciary, Real Estate Development, and Pension, Human Resources and Civil Service. She also serves as a Trustee on the Pension Board. In January, 2011, the Board of Commissioners appointed her to the Public Building Commission.

President Spyropoulos received her law degree from The John Marshall Law School and her MBA from Loyola University Chicago. She also completed graduate work in American government at Georgetown University, Washington, D.C. With her attorney experience, she brings a unique legal and business perspective combined with environmental activism. She has spoken to many community groups on environmental and water issues.

She is an attorney with the Law Offices of Mariyana Spyropoulos & Associates. Prior to opening her own law office, President Spyropoulos worked as an Assistant Cook County State's Attorney and then as a Hearing Officer for the State of Illinois. Before law school, she lived in London, England, where she worked at Nomura Research Institute. Her work focused on privatization efforts in Eastern European countries.

miles and provides wholesale wastewater treatment for over five million residents in Cook County, Illinois. The District operates seven wastewater treatment plants which treat one billion gallons per day. The District also provides regional storm water services. To understand the challenges involved in managing storm water and wastewater for five million Cook County residents, it is important to have an understanding of how the combined sewer system works. The entire Chicago land region developed on a flat marshland. In the past, water could gradually soak into the ground in open areas that are now covered with driveways, streets, parking lots, and buildings. Today, an estimated 42% of Cook County is impervious surface, so water cannot be absorbed. With more frequent 100 year storms happening, flooding is a major issue throughout Chicago land. Ms. Spyropoulos will give a PowerPoint presentation to help us better understand how the combined sewer system operates and discuss the work the District has underway to help reduce basement backups.

The February general meeting will be held on Wednesday, February 18, 2015 at the White Eagle. The dinner menu for the evening includes Cream of Chicken soup, Pepper Steak and Roast Chicken, Mostaccioli, a garden variety of vegetables and *kolaczki* for dessert. ART DECO POLAND 2 TRIP MAY 2015

POLAND! Home to 13 UNESCO World Heritage Sites! Imposing Castles! Lovely Scenery! Quaint Villages! Forest and Mountains! Folklore! History! Art Deco??? Yes! Poland adopted the style after a successful participation at the 1925 Paris Exposition.

In 1926 the port of Gdynia was opened. Construction of districts and individual structures were found in various cities. Polish artists created works that are still admired. Polish posters of the inter-war period were on the cutting edge. You can discover this aspect of Polish culture on the Art Deco Poland 2, May 09- 24, 2015 trip. This trip is a follow up from the success of the first trip in 2010 when Deco devotees (4 from Australia, 6 from Canada and 16 from the USA) visited six cities in Poland, highlighting their Art Deco sites.

Poland is still a bargain in Europe. The trip is scheduled for mid-May 2015, before the tourist high season, but still in pleasant travelling weather. Package tour prices are based on double occupancy, but single supplement is available. The land trip price includes: hotel accommodations in 4 and 5 star hotels, buffet breakfast daily, 6 dinners, air-conditioned motor coach, English-speaking tour escort, English-speaking guides in each city and admission to all attractions in the program.

Because of the various locations that people come from and their ability to use air mileage, travel to and from Poland is on your own. A certain amount of seats from Chicago will be reserved. The Museum of Polish Vodka is set to open in 2017 in Praga, a trendy location in the Polish capital, in two buildings left over from the former Koneser Distillery. Visitors will immerse themselves in the history of Poland's favorite spirit in five galleries. The development of the area will also include new cafes, boutiques, a gallery and apartments.

Poland's population growth rate was positive in 2014, according to the latest data of the Central Statistical Office (GUS) data. According to recent estimates, Poland will record some 380,000 births, up from 360,400 forecast by GUS back in October and 370,000 deaths, down from 384,000 previously forecast by GUS. Experts ascribe greater birth rate to recently introduced one-year-long paid parental leaves.

Polish movie theaters sold a record high 40 million tickets in 2014, helped by strong presentations of Polish films. The sector sold 38 million tickets in eleven months and the latest part of the Hobbit franchise helped boost sales to beat the 2009 record of 39.2 million tickets. The year was marked by strong sales of tickets for Polish films, which constituted some 35% of total sales.

Poland has announced plans to wage war on its quickly growing wild boar population after numbers of the feral animal increased by 150% in just 10 years. Foraging boars have become such a familiar sight in city suburbs as they target garbage cans for food that experts have warned they now pose a danger to the public. The Polish Hunting Association estimates that boar numbers have now reached 300,000, and without check the number will carry on growing. In response the government is preparing to relax hunting restrictions in an attempt to take a chunk out of the boar population. Polish boars have enjoyed a bonanza owing to a series of mild winters and increasing numbers of farmers growing more corn, a favorite boar snack, which has allowed them to fatten, breed and flourish.
