## **July 2019 Meeting and Speaker**





#### **KULZE SCHOLARSHIP**

As most of our membership is aware, former Chicago Society President, now deceased, Jim Kulze, and his wife, Lillian, generously endowed a scholarship fund as part of the Chicago Society Foundation that would be available for meaningful scholarships to worthy college and graduate school candidates with financial need. The Committee selected Emily Bienasz, attending Springfield College, Springfield, Massachusetts, Veronica Materna and Karolina Truszkowska, both attending Loyola University in Chicago, as the 2019 Kulze Scholars. Each will receive \$7,500. Their essays are being printed in several Forums.

## This month is the essay from Karolina Truszkowska.

Everyone has a story, a compilation of experiences, memories, emotions integrated into our intricately wired brains - the master of our personalities, dreams, behaviors, and virtually everything that makes us who we are. My brother and I were unfortunate and yet fortunate enough to survive and recover from a debilitating condition, a rare case of congenital bilateral vocal cord paralysis. While rendering us six years of daily trach-suctioning, six years of hospital visits, surgeries, stress, and our parents' recurring heart rendering stories, these experiences and recollections had a significant impact on who I am today. I am a twenty-year-old who spent half of her lift in Poland and more than half of it breathing in hospital air and walking down hospital corridors, things I evidently never let go and conceivably never will.

As a sophomore at Loyola University Chicago studying Neuroscience with a minor in Polish Studies, I take rigorous courses in biology, chemistry, and neuroscience in congruence with my major and the premedical track. From a young girl playing doctor, sewing up teddy bears and auscultating my parents, my interest in medicine never tempered, rather advanced from a fantasy to an aspired goal. Indubitably, my experiences coupled with my parents' poignant stories of my birth helped to instill this inexplicable passion I have for medicine and my sense of identification with the sick, especially children. Children are one of the most innocent, fragile, and vulnerable tiny humans, sometimes forced to fight debilitating, life-threatening conditions from the very first minute they are birth. Some are born prematurely and suffer from complications like undeveloped lungs, heart, GI tract, or slow growth and weight. Others are born with birth defects, congenital disorders, or omphalocele, organs growing outside of the body, all risking babies' survival. Neonatology, one of the most intensive subspecialties of pediatrics, involves the diagnosis, treatment, and care of such premature and critically ill newborns. Becoming one requires critical traits like compassion, determination, stamina, but also extensive knowledge acquired after years of vigorous studying, residency, and fellowship. Despite being a highly demanding and oftentimes painful profession, the rewarding outcomes, medical miracles, and my love for children are what motivate me to become a neonatologist, and as a premed student, I began my path in reaching that dream.

Unlike my childhood hospital visits, albeit certainty influential, my current healthcare endeavors intertwine with my compassion and career aspirations. Since high school, I have undertaken several volunteering positions that exposed me to a range of working environments of the medical and nursing staff. While interacting with patients, offering bedside support, nursing assistance, and observing a variety of conditions and incoming emergencies, I experienced an enriching preliminary healthcare exposure that further inspired me to become a nursing assistant. Despite the sometimes arduous and demanding aspects of being a CNA, the rewarding ones, such as helping long term nursing home patients or Alzheimer's patients with personal oare, bathing, dressing, or feeding, always suppress the latter. As it turns out, however, physical help not always suffices the innermost human needs. While working with a bed ridden and paralyzed elderly woman with expressive aphesis, I learned an important lesson. Despite her inability to articulate words, I noticed that nothing can bring out a more radiant smile on her face than simply talking to her, which many CNAs simply belittled. Notwithstanding the meaningful contributions of healthcare providers, our exceptional
