### **April 2018 Speaker & Dinner Meeting**

Our speaker for the April General Meeting will be our own **Brother Jan Plachta**. He will have a presentation on bridges built in America by Ralph Modjeski.

Jan Plachta was born in Kraków, Poland. In 1961 he moved to Vienna, Austria. In 1966 he graduated from the Technical University of Vienna with the Diplom-Ingenieur degree. In 1967 he immigrated to the United States and in 1972 he was awarded a Master of Science degree in Civil Engineering at the Illinois Institute of Technology in Chicago. In 1982 he received the Ph.D. degree from the Kraków Technical University. He worked for various consulting firms in the United States, Canada, Saudi Arabia, and for the Chicago District of the U.S. Army Corps of Engineers.

I hope everyone had a blessed Easter filled with hope and joy and surrounded by loved ones. As



we look forward to Divine Mercy Sunday, let's all take a moment to take stock of the tremendous gift we have in the graces our God offers daily. Principal among them is confidence in his boundless mercy. A simple Polish nun - Maria Kowalska, Sister Maria Faustina (now Saint Faustina), shared her revelation with the world almost 80 years ago and it is more relevant now than perhaps at any other time - God's mercy is boundless and can overcome any sin. We should be proud of the strong faith tradition that is interwoven into our Polish culture.

What's that Nietzsche'ism - "Whatever doesn't kill you makes you stronger"? I suspect you are all tired by now of the controversy and discord sparked by the debate over amending our Constitution to allow women members. The vote on this proposal is scheduled to take place at the April general meeting. The meeting will be at the White Eagle Banquet and Convention Center on April 18th beginning at 7:00 p.m. I encourage all members in good standing to attend and vote. Regardless the outcome, the matter will be resolved and we can put the division behind us with new respect for one another for the animating passions demonstrated out of concern for the Chicago Society.

However, before the vote I believe you should be aware of the troubling malaise sweeping the Chicago Society. As of April 1st, our Financial Secretary, Brother **Richard Wiermanski**, reported the suspension of 41 members for non-payment of dues. This number profoundly exceeds the delinquency in 2017. Perhaps the majority of the suspended members will cure their delinquency. That is my hope and for those who have not paid dues, I urge you to mail a check or pay on-line. It has never been easier. But the question I have is why are so many brother members (approximately 28%) not seeing value in membership? How can we increase our relevance and value to these men so that membership renewal becomes a reaffirming experience? I would appreciate your comments on how to improve our value to members. We have two upcoming events I invite you to attend. The first is our Constitution Day Parade Brunch. It is always well attended and paints the Chicago Society in a favorable light. If more members attended and spoke laudably of our organization and what we do for members and the community, perhaps some new membership would result. I look forward to seeing more of you at these events.

#### **Petition From the General Membership**

Originally printed in the March 2018 Forum:

Subsequent to a petition received from the general membership titled "Petition for the revisiting & voting on amending the Constitution of the Chicago Society PNA Lodge 1450 to allow women to become regular members", the following ammendment to the Chicago Society Constitution will be voted on during the April General Meeting scheduled for Wednesday, April 18, 2018. As stated in the Chicago Society Constitution, notice of such a vote must be published at least 14 days prior to the vote.

The specific language is as follows.

 Art III, Sec. 3A: Any male person of Polish lineage or affinity, over 18 years of age, of good character and reputation, whose acceptance will add to the welfare and progress of the Society and who is a citizen or legal permanent resident of the United States residing in Cook County or its contiguous counties may be admitted to membership in the Society at the discretion of the Board of Directors.

The addition of females will necessitate the following changes in various ar- ticles throughout the Constitution, as indicated below.:

Article III: Sec. 2: Replace the word "his" with "their."; Sec. 3 A: Replace the word "male" with the word "person."; Sec. 3 B: Delete the word "his."; Sec. 3 C: Delete the additional "C" and replace the phrase "his years" with the phrase "the duration."; Sec. 3 D: Replace "C" with "D."; Sec. 4: Delete the word "his" and insert the word "a."; Sec. 5: Delete the word "his" each place it appears. Sec. 6: Delete the word "his."

Article IV: Sec. 1: Delete the words "his" and insert instead the word "their." Further, insert the word "and" after the word "application."

Article VII: Sec. 9: Delete the last sentence and insert "No person administering the oath of office to the aforesaid officers and board members shall be one of the incoming officers or board members."

Article VIII: Sec. 1: Delete the semi-colon and the word "he" and insert a period after the word "Directors." In all other places "he" appears insert the phrase, "the Presi- dent."; Sec. 2: Each place appearing delete the words "he" and "his." In the last sen- tence delete the words "to him."; Sec. 3: Delete the word "he" in the first sentence. In the second sentence insert "Said officer" and delete the phrase "to him." Sec. 4: Delete the word "he" in each place it appears. Delete the phrase "to him." Sec. 5: Delete the word "he" in each place it appears. Delete the phrase "by him." Delete the phrase "to him." Delete "he shall give a bond for the faithful performance of his duties issued by a responsible surety company in an amount as approved by the Board of Directors, the premium for which shall be paid by the Society;". Replace it with "shall give a bond for faithful duty performance issued by a responsible surety company in an amount as approved by the Board of Directors, the premium for which shall be paid by the Society;" Sec. 6: Delete the word "he" each place it appears. Delete "he shall give a bond for the faithful performance of his duties issued by a responsible surety company in an amount as approved by the Board of Directors, the premium for which shall be paid by the Society;". Replace it with "shall give a bond for faithful duty performance issued by a responsible surety company in an amount as approved by the Board of Directors, the premium for which shall be paid by the Society;"; Sec. 7: Delete the word "his" and insert the word "the." Delete the phrase "to him."

Article IX: Sec. 6(E): Delete the phrase "to him." Sec. 7: Delete the Sec. and insert "Any Director may recommend the creation of such committees and members thereof who shall, under the direction of the President, assist in the performance of the President's duties.

His hobby is the history of American Bridge Building, he is an expert on Ralph Modjeski and his bridges and was instrumental in having a memorial plaque to Ralph Modjeski unveiled at the Copernicus Center in Chicago in 1991, and in 2008, in Bydgoszcz, Poland. He wrote a book titled: "Artist in Concrete and Steel – Bridges of Ralph Modjeski."

In addition to numerous technical publications in professional journals, he wrote articles in the local Polish press documenting the accomplishments of engineers of Polish heritage. In 1999 he became a Fellow of the American Society of Military Engineers and in 2006 was elected as a Fellow of the American Society of Civil Engineers (ASCE). He is a long time member of the Polish American Engineers Association. Currently he is serving as Recording Secretary of the Polish American Congress, Illinois Division.

#### **Kulze Scholarship Winners Announced**

Jim Kulze, a dedicated Society member and former President, and his wife Lillian, were strongly interested in helping young students be able to afford continuing their education, particularly in this age of rising costs of education and often the need to obtain substantial student loans. Toward that end, they very generously funded on their deaths the James and Lillian Kulze Scholarship Fund, part of the Chicago Society Foundation. The Fund this year provided three \$7,500 scholarship awards to deserving college and graduate school students. Aimed at academically superior students with financial need, these are among the largest available scholarship awards earmarked for Polish American students residing in Illinois.

This year, the awards are being made to Piotr Królikowski, studying medicine at the Jagiellonian University Medical School in Kraków, Poland, Sylwia Osos, a psychology major at Loyola University, and Monica Zawisza, studying finance and management information systems at DePaul. These worthy students were chosen from a highly competitive group of qualified applicants.

The Kulze Scholarship Committee chairman, Walter Piecewicz, thanks his fellow committee members, Mark Orwat, Steve Rakowski, Ro Matuszczak, and Ted Makariewicz, for their efforts in making the hard selections.

Winners will be invited to attend the Pre-Parade Brunch to be recognized, and the good works of our Chicago Society Foundation acknowledged. Essays prepared by the awardees will be published over the succeeding months in the Forum as space allows.
