MAY 2016 SPEAKER & DINNER MEETING

Our speaker at the May General meeting will be Piotr Wolodkowicz,

who will speak to us about the Polish Arts Club of Chicago, its history and future. Piotr Wolodkowicz was raised in Poland and is currently living in the U.S.A. since 1981, He came to America when he was 13, lived in L.A. before moving to Chicago with his family. He has been painting and drawing since he was a



little child. His work is in quite a few collections and on display in many businesses in the Chicago metro area and Europe. His art influences are modern artists like Picasso, Andy Warhol, Lucian Freud, and more classical like Sergant, Renoir, Malczewski, and Velazquez. He also loves the art of ancient Egypt and Greace. As a Polish born, yet American raised artist, he has a unique perspective that he incorporates into his work. Traveling the world has broadened and yet fined tuned the style of his brush. His art reflects his experiences and feelings. While painting and reflecting on life, he desires to show the places and the people that have influenced his understanding of the world. The mysticism of the people, and the uniqueness and depth of the visions are painted in a visually tantalizing fashion. His work can also be seen at his website, http://www.piotrart.com

The Polish Arts Club was officially chartered on February 14, 1926, with the following objectives:

- To broaden their knowledge, appreciation, and enjoyment of music, art and literature.
- To render moral and material aid to promising musicians, artists and writers.
- To promote Polish music, art and literature in the United States.

Since 1926, the Polish Arts Club of Chicago has initiated and promoted a wide variety of events, including public lectures on music, art, literature drama and history by authorities in their respective fields; concerts and exhibitions, and many others.

The PACC's longest running event is the Annual Exhibition of Painting and Sculpture. The first Exhibition was held in 1933. Since that time the Club has hosted a total of 74 annual Exhibitions, and it has grown to become the prominent art exhibition in the Chicagoland Area.

The Chicago Society held its Annual Pre-Parade Brunch celebrating the Polish Constitution at the Hotel Allegro on Saturday, May 7, 2016. CHCAGO SOCIETY FOUNDATION MEETING REVIEW

The Chicago Society Foundation met for its Quarterly Board of Directors meeting on Monday, April 25, 2016 at LaVilla Banquets in Chicago. Foundation Executive Vice President Brother Piecewicz served as chairman pro temp for the meeting. A grant of \$1,000.00 was approved for the Donald Gutowski Scholarship Foundation administered by the Polish Women's Civic Club. A grant was awarded by the CSF to Mr. Wojtek Sawa, founder of the Wall Speaks Project in 2014, a \$1,000.00 grant was given initially and the remaining \$4,000.00 was awarded in 2016 upon submission of a financial statement by the organization. The Foundation's total assets are \$654,659.05 as of April 25, 2016. The total assets for the Foundation increased by 48% due to a significant donation of \$314,912.23 from the Brother James Kulze Endowment, with his wish that it be used for educational scholarships. The next meeting of the CSF will be on Monday, July 25, 2016 at Smakosz Polish Restaurant in Chicago.
