

business and education, these men were the doers who routinely made things happen. Most of all, they were the ones who cared, who realized that ignoring the ills of society and of immigrants only intensifies problems.

Starting with the Boston Bibb & poached pear salad, to the entertaining Polonaise and Bialy Mazur, to the bowing of the debutantes, to the dancing to the excellent strains of the Anthony Kawalkowski Orchestra, to the crowning of the queen, and ending with the early morning buffet snack, the guests had an enjoyable soirée. Jarek Spychalski performed tremendous solos. Recognized at the scene were Mary and Henry Anselmo, Dee and Edward Blicharski, Dawn, Jeanette, and Keith Bode, Maria and Richard Ciesla, Morgan, Lori, and Hubert Cioromski, Darlene and Frank Czaja, Shirley Dudzinski, Alicia and Robert Dutka, Robert Flor and his siblings, Kenneth Gill, Katherine and Christopher Grzadziel, Joan Trandel and Edmund Gronkiewicz, Jennifer and Robert Groszek, Lucille and Donald Gutowski, Agata and Charles Komosa, Wanda Kurek and Joan Kosinski, Alexandra and Joseph Kuechel, Chris and Ro Matuszczak, Megan Boyle and Conrad Miczko, Stanislawa Rawicki, Marian Skawski, Patrick Rae and Judy Baar Topinka, and Anne, Marysia, and Michael Watson.

Designed in 1916 by the visionary architect Benjamin Marshall, 1530 North Lake Shore Drive, one of the finest surviving examples of the grand mansions which lined Lake Shore Drive at the turn of the last century, beckoned its guests to enter from the fierce winds and snow squalls from the lake. It was a soirée to warm the guests as tangos from Argentina and Poland along with dinner were provided to the patrons attending the Lira Ensemble benefit at the Consulate of the Republic of Poland. Lucyna Migala is Artistic Director of the group with Maria Ciesla, Jeanine Okonek, Matt Rodriguez, and Frances Wiet, among others serving on the Board.

Attending were Ron Kaftanski, Camille Kopielski, Chairman of the Board, Conrad Miczko, Ellen and Ron Olech (who a few months ago attended the wedding of their granddaughter in Connecticut where their eldest daughter lives), and Teresa and Marian Skawski.

Officially, delinquency was the reason for its (PAA) existence. "The Jackroller", a book written in 1930 by Dr. Clifford R. Shaw, head of the department of sociology, Illinois Institute of Juvenile Research, profiles the delinquent of the time. In this real life history, Stanley, the son of Polish immigrants, admits to being a runaway, vagrant, beggar, truant, shoplifter, petty thief, railroad thief, burglar and jackroller. As a result of these behaviors from ages 6 to 18, Stanley spends much of his young life in police stations, the Juvenile Detention Home, Chicago Parental School, St. Charles School for Boys, Illinois State Reformatory at Pontiac and the Chicago House of Correction. The Chicago Society members were determined to prevent a proliferation of Stanleys. Today the values and goals of the PAA have shifted to meet the needs of the 20th century population. During the fiscal year 2010, PAA served a record breaking 15,548 individuals. Yet, the need to raise funds continues. Hosting an annual gala is one of the ways to accumulate funds to operate. Tony Kawalkowski and his orchestra have been selected to provide dinner and dancing music. Conrad Miczko has been named Chairman of the Ball.

#### MEMBER OF THE MONTH

While you may have seen his face several times over the past few months at various Chicago Society events, Zenon Kurdziel has been active within the Polish community for many years.

degree, Zenon has quickly moved up the ranks – working for some of the industry's leading architectural firms in the Chicago area.

People encouraged others with their pictures of "Stand for Stan." "The day we started the project, the team (Cardinals) was in San Diego, and there were fans already in the stadium with "Stand for Stan" posters," said Watermon. "It took a life of its own and just grew, I am so happy to be here to see this. Everyone in the Cardinal Family got involved, including the players."

Musial was inducted into the National Baseball Hall of Fame and Museum in 1969 and the National Polish-American Sports Hall of Fame (NPASHF)in 1973. He played for the Cardinals as #6 for 22 seasons. The three-time National League MVP had won seven National League batting titles.


Musial helped the growth of Little League baseball in Poland and has acted as an unofficial emissary to the country. The Little League Baseball Training Center in Kutno, Poland is named after him. He was awarded Poland's Cavalier Cross of the Order of Merit.

#### VOYTEK PUTZ PRESENTS MONUMENT PLANS TO CITY

Chicago (PMN)—A town hall meeting was organized by the City of Chicago, held on February 8, 2011, during which the Chicago Chopin Foundation had an opportunity to present its project involving the proposed Chopin monument in Chicago. The Grand Park Conservancy extended an offer to let the foundation present its vision and plans to build and install an exact replica of the original Chopin's monument from Lazienki Park, Warsaw, in Grant Park in downtown Chicago.

The presentation panel consisted of the Chicago Chopin Foundation Board and a representative of the architectural firm that will present the preliminary proposal. There was also be a multimedia presentation, providing the overview of the entire project.

Voytek (Wojciech) Putz, President of the Chicago Chopin Foundation and a member of the Chicago Society, said, "Over the course of the past several years, we were always given words of encouragement and praise for this important cultural project. It is because of this support that we were able to come to this exciting and highly promising opportunity, where we can now present publicly our project





new developments are nevertheless highly encouraging, and the possibility of realizing our dream becomes increasingly less remote."

The proposed venue will feature an ongoing series of summer concerts in Grant Park under Chopin's monument in its full size and glory, exactly as they have been presented in Chopin's hometown of Warsaw for over a century. It is anticipated as an important addition to the already rich cultural scenery in Chicago, hopefully bringing international recognition.

#### **UNITED OR DIVIDED?**

Happy or not, the Chicago 2011 mayoral and aldermanic elections are over. We have the winner, the new mayor of Chicago, and time will only show whether the 55% of eligible voters who supported Rahm Emanuel on February 22 were wrong or right. I have been accused of being an optimist too many times, so I guess one more time won't hurt my feelings. I hope things will change for the better. Sometimes it may seem like they simply couldn't be any worse, but then again, I have underestimated different politicians and official figures before too. I suggest we all wait and see.

There were two significantly visible Polonia candidates in the last aldermanic election, Mrs. Anna Goral and Mrs. Anna Klocek. Unfortunately, none of them won the race, which

#### PLANS FOR JOHN PAUL II BEATIFICATION GIVEN

Vatican City (PMN)—Monsignor Guido Marini, Master of Papal Liturgical Celebrations, has stated that "It is very important to make as clear as possible that no tickets are needed, to attend the beatification of John Paul II."

The Prefecture of the Papal Household has issued a draft program for the Beatification of John Paul II, May 1, 2011. Describing it as "a great ecclesial event," the office in charge of organizing audiences and handles ticketing for all papal events at the Vatican, issued a statement February 18, 2011, that began "tickets are not needed to attend the beatification ceremony".

It added that no individual or institution can demand payment for improper deals as has become particularly common on the Internet. It also reaffirms that tickets are always free at papal ceremonies and general audiences.

Cardinal Jose Saraiva Martins, retired prefect of the Congregation for the Causes of Saints, has also confirmed an initial estimate of over 2.5 million pilgrims and faithful, from all over the world, for the ceremony of beatification of John Paul II

The ceremonies for the beatification have been divided into five phases. The first event is an open air vigil of preparation that will take place on the evening of Saturday, April 30, at the Circus Maximus. Organized by the diocese of Rome, it will be led by Cardinal Agostino Vallini, Vicar General for the Diocese of Rome. Pope Benedict XVI will join through a live video link.

The second phase is beatification ceremony itself, Sunday, May 1, in St. Peter's Square. The celebration, which will be presided by the Holy Father, will begin at 10:00 a.m. Immediately after the ceremony, the remains of John Paul II will be placed in front of the High Altar in St. Peter's Basilica, for the veneration by the faithful.

Access to the coffin, suitably embellished, will be allowed to pilgrims for a brief moment of prayer.

On Monday, May 2, Secretary of State Cardinal Tarcisio Bertone, will preside at a Mass of Thanksgiving at 10:30 a.m. in St. Peter's Square. Following this Pope John Paul II's remains will be "privately" reinterred in the side chapel of St Sebastian, in St Peter's Pasilica
