### **POLISH CONSTITUTION DAY PRE-PARADE BRUNCH**

The Chicago Society's Annual Polish Constitution Day Pre-Parade Brunch will be held on Saturday, May 2, 2015, in the Walnut Room of the Hotel Allegro, 171 W Randolph St, Chicago, Illinois.

The cost of the brunch is \$35.00 per person. Reception will be at 8:45 a.m., seating at 9:45 a.m., and a delicious plated brunch will be served at 10:00 a.m. The invocation will be given by Bishop Andrew Wypych. Brother Ted **Makarewicz** will present monetary awards to our scholarship recipients, who will be announced by Scholarship Chairman **Brother Robert Groszek**.

The parade is scheduled to step off at 11:30 a.m. Duke men's basketball coach Mike Krzyzewski, a Chicago native, will serve as grand marshal for May 2's Polish Constitution Day Parade and is planning to attend the brunch.

This is the 124th Chicago parade in honor of this historic document, the first democratic constitution in Europe and second in the world only to the United States Constitution. The Chicago Society will have a float and marching unit in the Parade. There will be a band on the float and space for some persons to sit.

Those members who will not attend the brunch but will march can contact Chairman **Ro Matuszczak** or Brother **Frank Czaja** (official float chairman) as to our place in the parade. Information on the day of the event can also be obtained from any parade marshal. Preferred attire for the marchers is gray slacks, dark jacket, red tie and white shirt. A business suit is certainly acceptable.

Brother Matuszczak has been involved with the Brunch since its inception in May, 1978, making this his 38th year. Co-chairmen are Brother **Charles Komosa** and Brother **T. Ron Jasinski-Herbert.** Absolutely no tickets will be available at the door and all tickets must be prepaid!

Television coverage of the parade will be provided by ABC-7 and Polish stations. The parade route starts at Dearborn St. and proceeds from Lake to Van Buren, and begins at 11:30 a.m.

If Poland realizes the more ambitious of two scenarios, it could become an economic powerhouse over the next decade, says a February, 2015, report by management consulting firm McKinsey & Company. Poland has two options, the report by the NY-based firm, said. "Under a conservative, business-as-usual scenario, Poland's GDP would grow at a moderate rate of 2.6% annually — the average rate since 2008." However, should Poland choose an accelerated growth path to 2025, the country could "move from the eighth to the seventh largest economy in the EU," "become the third-largest process manufacturer in the EU," and "attain levels of Italy, Spain and Portugal in GDP per capita."



Minister of National Defense Tomasz Siemoniak said on February 26, 2015, Poland plans to send several dozen military instructors to Ukraine. "We want to train up to 100 instructors," he said, adding that the exact number of instructors would be agreed with the Ukrainian side, as would be the time when they were to be sent to Ukraine.

The Polish Ministry of Defense has confirmed that funds to purchase new submarines are already reserved, but it is during the 4th quarter of this year, when the Ministry is going to start the analyses of options, that they will be used to launch the acquisition process.
