"I have dedicated most of my professional career to the PAA's mission to serve the diverse needs of the Polish community in the Chicago metro area by providing resources for changing lives," said Dolas. "We are delighted that Dolas is becoming the new Executive Director. She has a superb record of leadership and service," said Adam Kamieniak, Chairman of PAA's Board of Directors. "Through her leadership, PAA is certain to continue to grow and develop new and unique programs to serve the Polish community."



Founded in 1922, the Polish American Association is the nation's only human services organization providing a comprehensive range of bilingual and bicultural services to the Polish community and others in need. In 1922, the Chicago Society incorporated the Polish Welfare Association, the precursor to the Polish American Association. The Chicago Society Foundation has annually awarded grants to the Polish American Association to assist them in their welfare programs, ranging from \$5,000 to \$10,000. This past January the Chicago Society Foundation board of directors awarded the PAA \$5,000 to allow the homeless victims in winter to survive with food, shelter and warm clothing.

The February General Meeting not only offers great camaraderie, a featured speaker, but a delicious dinner menu! *Below is the address given by Brother President
Steven Rakowski at the Inaugural Ball.*

My Chicago Society Brothers, representatives of our brother Polish organizations, and honored guests,

It is an honor to be here with you tonight and to share with you my hopes and goals for the Chicago Society for the future.

Who among you (except Ro, who was here when our Constitution was signed) knows that the Chicago Society has been around 105 years? That's a long time, and during that time Chicago Society has developed a great deal of traditions. As a group, we have accomplished much. But the Chicago Society, like most other organizations serving Polonia today, can do so much more.

What happened to those days when Polish aldermen represented Polish wards? Why is the number of Polish judges dwindling? Where are our influential leaders in the tradition of Rozmarek, Pucinski, Mazewski, and Moskal. One reason could be that Polonia no longer thinks or acts as a group. We each have our own pet projects and affiliations and by and large the left hand doesn't know what the right hand is doing.

So what do we do? In 1st John we read the entreatment to "love not in word but in deed and truth." By serving one another, getting involved, networking, joining, we make the most genuine expression of our concern for each other and for Polonia. I know I'm preaching to the choir because you are here, participating, supporting. But if each of us can convince just one other person to support an initiative benefitting Polonia in 2017, supported a Polish candidate for office, undertook a leadership role in the Chicago Society, we would double our voice. And that's what it's all about! With a greater voice, we have greater influence and greater ability to help Polonia and our fellow Poles.

By reaching out and modeling the lesson in 1st John, and supporting other Polish organizations, I hope to create more public understanding of the Chicago Society and its value to its members and the community-at-large. With a greater presence in the community, we can offer greater incentives for people to join. That's what it really comes down to: membership, energy, creativity, new ways of solving problems. I'm going to pursue the growth of the Chicago Society, both in size and influence.

I have many people and much to be thankful for. First, thanks to Brother Ro and his lovely wife Chris for organizing this elegant affair. If you are enjoying yourselves this evening, please join me in expressing our appreciation by giving them a round of applause. Thanks also to Brother Ted Makarewicz for all of his behind the scenes work to make the Chicago Society and me look good. Thanks also to Hon. John Wasilewski for administering the oath of office to our incoming officers.

Thanks to everyone in the Chicago Society who supported me for this office. I'm not sure what I did to justify this trust, but I promise you I will work hard to maintain it. And on behalf of all Chicago Society members, thank you all for joining us tonight. We truly value your support and your friendship. God bless you all. Good night!

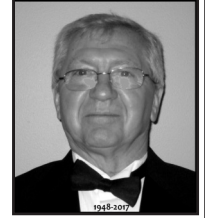
The culmination of the evening was the Installation of the new Board by Hon. John Wasilewski, who administered the oath of office to the officers and wished them much success in the coming year. He then individually
