The evening began with cocktails followed by dinner featuring herring (Słedź) in cream sauce, salad, pasta, a choice of Chicken Marsala and for our really devout Catholic brothers, Salmon with mixed vegetables. # **Petition From the General Membership**

Subsequent to a petition received from the general membership titled "Petition for the revisiting & voting on amending the Constitution of the Chicago Society PNA Lodge 1450 to allow women to become regular members", the following ammendment to the Chicago Society Constitution will be voted on during the April General Meeting scheduled for Wednesday, April 18, 2018. As stated in the Chicago Society Constitution, notice of such a vote must be published at least 14 days prior to the vote.

The specific language is as follows.

 Art III, Sec. 3A: Any male person of Polish lineage or affinity, over 18 years of age, of good character and reputation, whose acceptance will add to the welfare and progress of the Society and who is a citizen or legal permanent resident of the United States residing in Cook County or its contiguous counties may be admitted to membership in the Society at the discretion of the Board of Directors.

The addition of females will necessitate the following changes in various ar- ticles throughout the Constitution, as indicated below.:

Article III: Sec. 2: Replace the word "his" with "their."; Sec. 3 A: Replace the word "male" with the word "person."; Sec. 3 B: Delete the word "his."; Sec. 3 C: Delete the additional "C" and replace the phrase "his years" with the phrase "the duration."; Sec. 3 D: Replace "C" with "D."; Sec. 4: Delete the word "his" and insert the word "a."; Sec. 5: Delete the word "his" each place it appears. Sec. 6: Delete the word "his."

Article IV: Sec. 1: Delete the words "his" and insert instead the word "their." Further, insert the word "and" after the word "application."

Article VII: Sec. 9: Delete the last sentence and insert "No person administering the oath of office to the aforesaid officers and board members shall be one of the incoming officers or board members."

Article VIII: Sec. 1: Delete the semi-colon and the word "he" and insert a period after the word "Directors." In all other places "he" appears insert the phrase, "the Presi- dent."; Sec. 2: Each place appearing delete the words "he" and "his." In the last sen- tence delete the words "to him."; Sec. 3: Delete the word "he" in the first sentence. In the second sentence insert "Said officer" and delete the phrase "to him." Sec. 4: Delete the word "he" in each place it appears. Delete the phrase "to him." Sec. 5: Delete the word "he" in each place it appears. Delete the phrase "by him." Delete the phrase "to him." Delete "he shall give a bond for the faithful performance of his duties issued by a responsible surety company in an amount as approved by the Board of Directors, the premium for which shall be paid by the Society;". Replace it with "shall give a bond for faithful duty performance issued by a responsible surety company in an amount as approved by the Board of Directors, the premium for which shall be paid by the Society;" Sec. 6: Delete the word "he" each place it appears. Delete "he shall give a bond for the faithful performance of his duties issued by a responsible surety company in an amount as approved by the Board of Directors, the premium for which shall be paid by the Soci- ety;" Sec. 6: Delete the word "he" each place it appears.
